  4. Provide access and training on materials and resources available through the Healing Communities web site, and all other information contained therein.
  5. Convene the Healing Communities network through webinars and/or conference venues on a regular, or as requested basis.
  6. Provide feedback, data and information based on gathering of information from quarterly filed reports.
  7. Provide access to the Community Impact Institute's capacity building project at a reduced rate.
